## **President's Report**

Azeem Ahamed, MPBIA president's remarks were read to those in attendance. Staff were recognized for their work in the neighbourhood. The members of the board were also acknowledged for their contribution to the "hood" as a place they were proud to call home.

#### **Beautification**

Details of the effort to provide plaza enhancements and graffiti removal efforts were reported. Planters and hanging baskets were installed and the Clean Teams were on duty six days a week in the area and were responsible for the removal of many tons of garbage and debris.

Future plans included increases in the Clean Team size and frequency, new banners and highlighting the history and art of the area. Plazas were to undergo major renovations and a new lighting project was underway.

A presentation of the 2022-2023 highlights included mention of the many Michelin restaurants. The MPBIA social media continued to bring attention to the neighbourhood. Security partner Kevlar Security had a dedicated team in the area offering a variety of services including training for the members.

At this point in the meeting Cathy O'Connor Morris, Executive Director of the Mount Pleasant Community Policing Centre (CPC) addressed the meeting. The CPC was recruiting volunteers with a goal to find 100 people to participate in this program.

## 7. Expanding the BIA

The ED explained that MPBIA had been approached by businesses in the area south from 19<sup>th</sup> to 29<sup>th</sup> to be included in the MPBIA. As a result it was recommended that approval be sought from the City Council in the fall 2023, aiming BIA activities in this expanded area in April 1<sup>st</sup> 2024.
